# 4. FIRST AID MEASURES

ventilation. If inhalation risk exists wear organic vapour/particulate respirator meeting the requirements of AS/NZS 1715 and AS/NZS 1716. # **5. FIRE FIGHTING MEASURES**

**Suitable extinguishing media:** If material is involved in a fire use alcohol resistant foam or dry agent (carbon dioxide, dry chemical powder).

**Specific hazards:** Highly flammable liquid and vapour. May form flammable vapour mixtures with air. Flameproof equipment necessary in area where this chemical is being used. Nearby equipment must be earthed. Electrical requirements for work area should be assessed according to AS3000. Vapour may travel a considerable distance to source of ignition and flash back.
